

AN ORDINANCE ESTABLISHING THE COMPENSATION OF CERTAIN ELECTED OFFICIALS
(Trustee Compensation--Annual Basis--Commencing 4/07)

WHEREAS, the provisions of 65 ILCS 5/3.1-50-10 authorize the corporate authorities of a municipal corporation to fix by ordinance the salaries of municipal officers elected for a fixed term, provided that no such salary may be increased or diminished during the then-current term of any such officer, and provided further that any such ordinance shall be adopted not less than 180 days before the terms of the officers whose compensation is to be fixed; and

WHEREAS, the Corporate Authorities of the Village of Homer Glen have determined that the compensation for the Village Trustees to be elected at the April 5, 2005 election and at each election of Villages Trustees thereafter should be revised as set forth in this Ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF HOMER GLEN, WILL COUNTY, ILLINOIS, THAT:

Section 1: Recitals – The foregoing recitals are hereby incorporated into this Ordinance No. 04-072 as if fully set forth herein.

Section 2: Compensation -- Effective upon the election of and swearing in of all Village Trustees to be elected at the April 2007 Consolidated Election, all Village Trustees then duly and lawfully holding office (including all Village Trustees elected at the April 5, 2005 Consolidated Election) shall receive compensation in the annual amount of \$6,000.00 , to be paid in equal monthly increments.

Section 3: Severability - The various portions of this Ordinance are hereby expressly declared to be severable, and the invalidity of any such portion of this Ordinance shall not affect the validity of any other portions of this Ordinance, which shall be enforced to the fullest extent possible.

Section 4: Repealer - All ordinances or portions of ordinances previously passed or adopted by the Village of Homer Glen that conflict with or are inconsistent with the provisions of this Ordinance are hereby repealed.

Section 5: Effective Date - This Ordinance shall be in full force and effect from and after its passage and approval.
