Submittal Requirements:

- Certificate of Insurance- (verifying the golf cart type vehicle any operator is covered by public liability insurance for personal injury & property damage)
- Signed Waiver/Release of Claims & Indemnification Agreement
- Signed Applicant Certification/Checklist- (for required safety equipment)
- Initial Application Fee of \$100.00 (\$50.00 annual registration fee will apply each year)

*Once the certificate of registration sticker is issued, the driver **MUST** be in possession of a current sticker at all times when the golf cart type vehicle is in operation on the village streets. The sticker will expire on April 30th of each year and will need to be renewed annually. The Village has the right to revoke the certificate for noncompliance of the ordinance. _____ (initial)

Required Regulations

Safety Equipment:

- Brakes
- Steering wheel apparatus
- Tires
- Rear view mirror
- Horn or warning device
- Red reflective warning devices on the front and rear
- A slow-moving vehicle emblem on the rear of the non-highway vehicle
- A headlight that emits a white light visible from a distance of at least 500ft to the front
- A tail lamp that emits a red light visible from a distance of at least 100ft from the rear
- Brake lights
- Turn signals (which may be communicated by the driver with hand signals)

Regulations Specific to Golf Cart type vehicle: (when on any village road)

- Any person 18 year of age or older, with a valid driver's license, may operate a golf cart type vehicle on the village roads.
- The golf cart type vehicle shall have its headlights & tail lamps lighted at all times.
- Any person operating a golf cart type vehicle shall travel on the roadway with a posted speed limit of 30 miles per hour or less in the same direction as traffic and as near to the right side of the roadway as possible.
- Any person operating a golf cart type vehicle on any village roadway shall obey any and all traffic regulations set forth either in the Village of Homer Glen Code or in the Illinois Vehicle Code.
- Golf Cart type vehicle will be allowed to cross a road only at an intersection of the roadway with another roadway at a place with no obstructions to prevent a quick & safe crossing.
- Golf Cart type vehicle shall **NOT** exceed a speed of 30 miles per hour.
- No golf cart type vehicle may be operated on sidewalks, bike trails, or other public property not accessible to or authorized for vehicular traffic.
- Appropriate child restraint is required for any child under eight years of age.

***Violation/Penalty-**The operator or owner of any off-road motor vehicle who violates any provision of the Ordinance shall, upon a finding of liability, be fined not less than One Thousand Dollars (\$1000.00) but no more than Two Thousand Five Hundred Dollars (\$2500.00) for each offense.

GOLF CART WAIVER/RELEASE OF CLAIMS AND INDEMNIFICATION AGREEMENT

As the owner of the registered golf cart, I have reviewed Article VII of Chapter 200 of the Village Ordinance and agree to ensure that my golf cart is operated in compliance with the terms of the ordinance. I understand that golf carts are not designed with the same safety standards as regular highway approved cars/trucks/vehicles and are not designed to be operated on roadways. I understand and acknowledge that operating a golf cart on public roadways is inherently dangerous and that by operating my golf cart on public roadways I am accepting such risks for myself and everyone I allow to operate or utilize my golf cart.

As the owner of the registered golf cart I have read, understand and acknowledge the paragraph above and I agree to waive any and all damages or claims against the Village of Homer Glen related to the operation of my golf cart. In addition, I agree to hold harmless and indemnify the Village of Homer Glen against any and all claims related to the operation of my golf cart on Village Roadways.
