I felt embarrassed and ashamed because he was alluding to the fact it was my fault for asking questions. Now I don't even want to leave the house because I believe everyone is singling me out because I feel he told all the other neighbors that I was banned. I don't think I'll be able to regain my stellar reputation in my neighborhood, all caused by possibly one individual who removed my posts and then banned me. Whoever that person who banned me should resign immediately, and I will NOT accept an answer of "we don't know who did this".
