The fertilizer will give the grass vital nutrients to ensure a healthy, green lawn while the crabgrass preventative and weed control will maintain the aesthetic beauty of the turf by ridding it of unsightly weeds. **\$415.00**

Early Summer Application w/Grub Preventative

(June-July) This application consists of a balanced time-release fertilizer, weed control and grub preventative applied at the proper time to ensure maximum results. Because insects become active at this time, the property will be inspected at the time of application for *surface* turf-damaging insects. If any are found corrective measures will be taken at no additional cost, and property owner will be notified of technician's findings. **\$440.00**

Summer Application

(July-August) This application consists of a balanced, time-release fertilizer and weed control specifically designed to strengthen and feed the lawn during the hot and dry months of late summer. The fertilizer will slowly feed the grass root systems with balanced nutrients needed to sustain the grass during peak periods of stress. Weeds will also be treated with a spot-spray to minimize stress to the lawn. **\$415.00**

Late Summer/Early Fall Application

(September-October) This application consists of a balanced time-released fertilizer and broadleaf weed control. The fertilizer will strengthen root development, helping the lawn to recover from the stress of the summer months, while the weed control will eliminate unsightly weeds from the ornamental grass. **\$415.00**
