Required Submittals*:

- A site plan which indicates all signage, including banners and all temporary signs.
- A Parking and Circulation Plan which must show stalls, circulation paths, access locations and traffic control devices, provided such Plan shall not be required for Special Events located in residential districts on lots without on-site parking.
- A Sanitary Facilities Report from Will County Health Department confirming compliance with all applicable Health and Sanitation Codes, provided such requirement may be waived by the Village.
- A Traffic Control and Security Contract and Emergency Management Plan (if required) to provide for off-duty police officers, trained security personnel or trained emergency management personnel to provide traffic control, security and emergency management provided such requirement may be waived by the Village.
- When the applicant for a Special Event is not the owner of the lot on which the event will occur, the applicant shall submit proof of the owner's authorization which shall be in writing, dated, signed by owner and contain sufficient information so as to identify the property and the proposed Special Event.

* Such other information as the Village Manager reasonably deems necessary to properly prepare for and/or evaluate the potential impact on the public health, safety, and welfare

If event is held on public property, the following is required:

- A Certificate of Liability Insurance and Indemnification Agreement shall be required and shall name the Village of Homer Glen as a co-insured, if the event is held on public property. An Indemnification Agreement shall also be executed separately or be part of the insurance policy.
 - *General Liability Limits: \$1,000,000 each occurrence / \$2,000,000 aggregate*
 - *Auto Liability Limits: \$1,000,000 combined single limit \$1,000,000 / \$1,000,000 underinsured motorist*
 - *Umbrella Liability: \$5,000,000 each occurrence / \$5,000,000 aggregate*
 - *Workers Compensation: \$1,000,000 each occurrence*
 - *All pertinent endorsements to be attached to the Certificate of Insurance*

- A Bond or Letter of Credit may be required with the Village to guarantee removal of all temporary structures, tents, junk, debris, and other personal property from the lot upon.

Hold Harmless Statement

The applicant hereby agrees to indemnify and hold harmless the Village of Homer Glen, its Corporate Authorities, officers, agents, and employees from and against any and all claims, suits, damages, causes of action, judgments, loss, costs, expenses, and attorney's fees arising out of personal injury, including death, property loss or theft sustained by any person on the premises during or as a result of the applicant's permission to hold an activity/event or use of municipal property.

I hereby further certify that the information provided in this application is true and correct to the best of my knowledge and that I have not provided false or misleading information. I understand that the failure to supply adequate or correct information will be subject to revocation of permission to hold such an activity/event or use of municipal property.

For Food Trucks: I agree to abide by the Food Vendor information and Rules. My food truck is self-contained and requires no extra electricity. I will obtain necessary Will County Health Department permits.

I agree to provide a Certificate of Insurance including the Endorsement Page, naming the Village of Homer Glen as Additional Insured. General Liability limits of no less than \$1,000,000 per occurrence / \$2,000,000 annual aggregate. Coverage dates on the insurance certificate include the event dates. The event location should be listed on the Certificate of Insurance as 14240 W 151st Street, Homer Glen, Illinois, unless at a different Village property, then please specify that location address.
